ALL entries must be received by Monday, September 29, 2025, no later than 1:00 p.m. EST. NO late entries will be accepted.

ALL participants must be amateur photographers – contest is NOT open to professional photographers. Maximum of 4 photos may be submitted per entrant. Photos MUST be taken inside Polk County, Tennessee and should not contain any identifiable person(s).

## Terms and Conditions

The Polk County Chamber of Commerce is presenting a distinctive photo contest opportunity for our 2026 calendar – For the Love of Polk County.

1. ALL photos must be taken INSIDE Polk County, TN. Photos should NOT contain any identifiable person(s).
2. Photos may be submitted in print form, downloaded onto a CD/flash drive, or emailed to the Chamber office. Entries will be accepted via US mail or can be dropped off at the Chamber office. Digital photographs must be in .jpg, .jpeg, or .gif format and must be a minimum of 300 dpi. Prints should be no larger than 8X10 in size, **HORIZONTAL** in orientation. Only horizontal photos will be voted on.
3. Participant must complete the application form and submit it along with photograph(s). If submitting photographs via email, applications will be accepted by mailing to the Chamber office or a scanned copy may be sent via email with the photos. APPLICATION MUST BE RECEIVED BEFORE THE ENTRY PROCESS IS COMPLETE.
4. All photographs entered must be free of any copyright infringements or the right to distribute without restriction has been secured.
5. Participant must include a completed Entry Form with their application.
6. All entries become the property of the Polk County Chamber of Commerce. Photographs will be used by the Polk County Chamber of Commerce for promotional and marketing purposes and will not be returned.
7. Participants agree to the use of the entry by the Polk County Chamber of Commerce and its agents and employees for display and use, in part or entirety, in any of its communications, publications and web sites, including where applicable the name of the photographer.
8. The Polk County Chamber of Commerce reserves the right to disqualify any entry that does not comply with the terms and conditions set forth. Any material deemed obscene, offensive, or otherwise inappropriate for viewing by a general audience or infringes upon any third party's intellectual property rights will be automatically disqualified.

Participants agree that any attempt by an entrant or other individual to deliberately damage any website or undermine the legitimate operation of the Polk County Chamber of Commerce is a violation of criminal and civil laws, and should such attempt be made, the Polk County Chamber of Commerce reserves the right to seek damages to the fullest extent permitted by law.
